### About Speaker



Veerathai Santiprabhob is the 23rd Governor of the Bank of Thailand, with a five-year term starting on October 1st, 2015. He is a macroeconomist, strategist, and financial professional with more than 20 years of

experiences in economic policy design, commercial banking, and capital market.

He began his career in 1994 as an economist at the International Monetary Fund in Washington, DC before serving as a co-director of the Policy Research Institute of the Thai Ministry of Finance during the 1997 Asian financial crisis. In 2014, Veerathai was appointed to be a member of the Bank of Thailand’s Board and Monetary Policy Committee. He was an advisor of Thailand Development Research Institute (TDRI). In private sector, Veerathai was a senior executive of Siam Commercial Bank, PCL and The Stock Exchange of Thailand. He held various positions at the boards of leading corporations, including Thanachart Capital PCL, Bangkok Dusit Medical Services PCL, Thai Airways International PCL, and Central Pattana PCL.
