Dr. Bandid Nijathaworn is presently President and CEO of the Thai Institute of Directors, Visiting Professor, Hitotsubashi University, Tokyo, Japan, and member of the Council of trustees and the board of directors of Thailand Development Research Institute.

Dr. Bandid is a well-known economist with a long working experience in macroeconomic and financial issues, including at the IMF where he joined as a young professional in the IMF Economist program. He is widely recognized as a keen commentator on regional and global policy issues and contributes actively to policy discussion and capacity-building in the ASEAN region. In June 2012, he was invited to join the IIF's Joint Committee on the Strengthening of the Framework for Sovereign Debt Crisis Prevention and Resolution and the Special Committee on Financial Crisis Prevention and Resolution, and was Chairman of the Thai Bond Market Association from May 2011 to April 2014.

Dr. Bandid left the Bank of Thailand in November 2010–where he joined in 1990 and held the positions of deputy Governor for monetary stability and for financial stability since 2004-- to work on improving Thailand's corporate governance and manage the country's private sector anti-corruption initiative under the capacity of President and CEO of the Thai Institute of Directors. He writes regularly for the Bangkok Post and for his weekly column in a leading Thai business daily on economic and governance issues. He frequently lectures and chairs high-level policy and investors meetings throughout Asia including Japan and Singapore.

### **VEERATHAI SANTIPRABHOB, PH.D.**

#### Governor, Bank of Thailand

Veerathai Santiprabhob is the 23rd Governor of the Bank of Thailand, with a five-year term starting on October 1st, 2015. He is a macroeconomist, strategist, and financial professional with more than 20 years of experiences in economic policy design, commercial banking, and capital market. He began his career in 1994 as an economist at the International Monetary Fund in Washington, DC before serving as a co-director of the Policy Research Institute of the Thai Ministry of Finance during the 1997 Asian financial crisis. In 2014, Veerathai was appointed to be a member of the Bank of Thailand's Board and Monetary Policy Committee. He has also been a member of the State-Owned Enterprise Policy and Supervisory Committee and was an advisor of Thailand Development Research Institute (TDRI). In private sector, Veerathai was a senior executive of Siam Commercial Bank, PCL and The Stock Exchange of Thailand. He held various positions at the boards of leading corporations, including Thanachart Capital PCL, Bangkok Dusit Medical Services PCL, Thai Airways International PCL, and Central Pattana PCL. Veerathai received his B.A. (first class honors) in Economics from Thammasat University in 1988 and was awarded H.M. the King Bhumibol Adulyadej award for academic excellence. He went on to receive A.M. and Ph.D. in Economics from Harvard University in 1994. His graduate study was sponsored by H.M. the King's Anandamahidol Foundation.

Veerathai has actively participated in social activities. He has served as the treasurer of the Royal Initiative Discovery Foundation, a member of the executive board of the Buddhadasa Indapanno Archives, a member of the board of Mae Fah Luang Foundation, a member of the board of the Thailand Sustainable Development Foundation, and an honorary member of Thammasat University Council. He was a member of the first Independent Expert Oversight Advisory Committee of the World Health Organization in Geneva and was awarded the Eisenhower Fellowship in 2013.

Andrew Sheng is Distinguished Fellow of Asia Global Institute, The University of Hong Kong. His latest book is "Shadow Banking in China: An Opportunity for Financial Reform," with Ng Chow Soon (2016, John Wiley).

### **RAPEE SUCHARITAKUL**

#### Secretary-General, Securities and Exchange Commission, Thailand (SEC)

Mr. Sucharitakul is the Secretary-General of the SEC, Thailand. Concurrently, he serves as a member of the State Enterprises Policy Committee.

Mr. Sucharitakul joined SEC at its establishment and devoted 13 years of his career to capital market development and supervision. He left the SEC in 2005 to take on several positions in private and public organizations, where he gained extensive experiences in policy making, consultancy and management. Some of his previous posts include member of the Board of Governors of the Stock Exchange of Thailand, director of Thailand Futures Exchange, director of the Federation of Thai Capital Market Organizations, director of the Thai Institute of Directors Association, director of KASIKORNBANK Plc., executive chairman of KASIKORN Securities Plc. and KASIKORN Asset Management Company Limited, advisor to the President of Muang Thai Life Assurance Plc., and independent director of Big C Supercenter Plc. He rejoined the SEC in his current role in May 2015.

Mr. Sucharitakul earned an LLM in Commercial Law from University of Bristol, and an LLB (with honors) from University of Essex, the United Kingdom.

Pru Bennett is a Managing Director at BlackRock and is Head of BlackRock's Investment Stewardship team for the Asia Pacific Region based in Hong Kong. In that role Pru leads a team that is responsible for engagement and proxy voting activities in relation to the companies in which BlackRock invests on behalf of clients. Pru's team is located in Hong Kong and Tokyo.



Pru is an active participant in the public debate on corporate governance, stewardship and responsible investment and as such regularly speaks and writes on the importance of these issues for company performance and investment decisions. In 2013, Pru was named as one of Australia's top 10 Women of Influence in Corporate Governance. Pru represents BlackRock on a number of industry and regulatory bodies including ESG Working Group of the Australian Financial Services Council and the Public Shareholder Group of Hong Kong's Securities and Futures Commission.

In April 2017 Pru was appointed by the Government of Hong Kong to the Advisory Board to the Securities and Futures Commission.

Pru is a champion of diversity and inclusion of all kinds. She is an alumna of BlackRock's Women's Leadership Forum. She is a member of steering groups for the Australian and Hong Kong chapters of the 30% club, a market initiative to increase the number of women on boards and in senior management. Pru has published a number of papers on board diversity.

Before taking on her current role in August 2010 Pru was head of Corporate Governance at institutional advisor Regnan Governance and Research until July 2010. From 1998 to 2009 Pru was a director of Australian proxy advisor Corporate Governance International, which was acquired by Glass Lewis & Co in 2006 and is now known as CGI Glass Lewis. Prior to working in the area of corporate governance Pru was Investor Relations Manager for Qantas Airways Limited.

Pru has a BCom from the University of New South Wales and is a member of the Institute of Chartered Accountants Australia and New Zealand.



He is a member of the B20 group of international business leaders who dialogue with G20 governments. He is also a member of the EU's multistakeholder platform on the implementation of the Sustainable Development Goals in the EU. Richard has spoken widely on issues of financial stability, sustainable development and capital market reform as part of the United Nations Forum on Business and Human Rights, the OECD Forum on Responsible Business Conduct, the UNCTAD Expert Group on International Standards of Accounting and Reporting and at other international fora.

In this capacity, he was key architect of the EU's non-financial information directive, one of the biggest transformations in corporate disclosure anywhere in the world.
