Singapore shares slip as US technology selloff spreads

SINGAPORE (Nikkei Markets) -- Singapore shares edged lower on Monday as sentiment in Asia took a hit after a selloff in U.S. technology stocks prompted a decline their regional peers.

The Nikkei Asia300 Index fell 0.9%, with technology stocks pacing declines after steep losses in Apple, Facebook, Alphabet and Microsoft took the Nasdaq Composite down almost 2% on Friday. Hong Kong-listed Tencent Holdings fell 2.5% and Apple-supplier AAC Technologies Holdings declined 3.8%. Samsung Electronics lost 1.6% in Seoul, and Hon Hai Precision Industry and Taiwan Semiconductor Manufacturing Co. shed at least 2.2% each in Taipei. U.S. stock futures pointed to second day of losses for the Nasdaq.

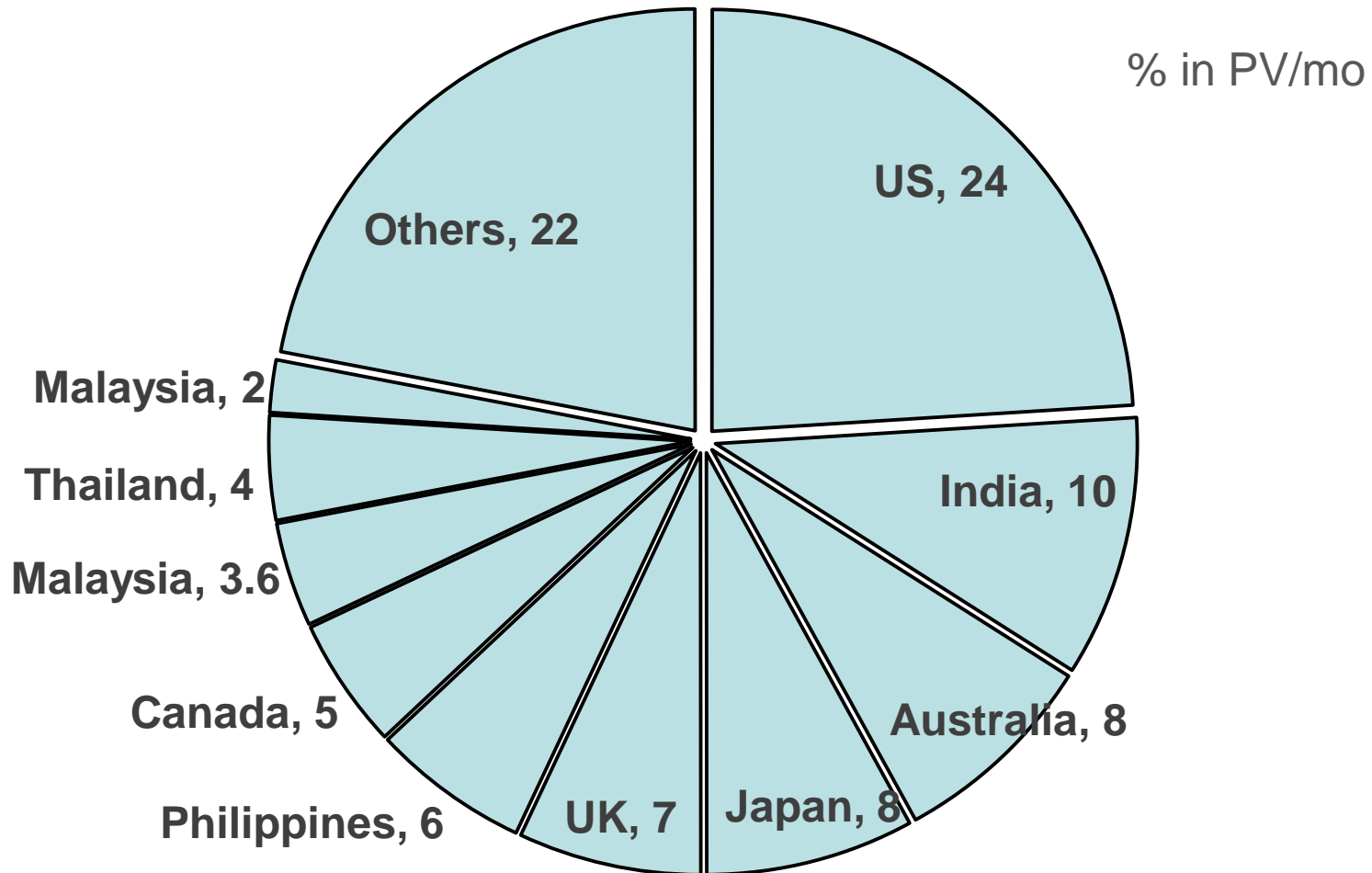
